MANDATORY RULES REGARDING UNIVERSITY EXAMINATION

- (1) Minimum 75% attendance is required in each subject during the academic year.
- (2) Student should appear in all the tests and examinations conducted by the College as per University norms and has to score atleast minimum passing marks.
- (3) Code of Conduct of the college should be followed.
- (4) All dues should be cleared.

Note: Any failure to follow the above rules may result in suspension from the college or debarring from University Examinations.

GENERAL RULES

- 1. Student who joins for any programme is expected to abide by the Rules and Regulations of the college.
- 2. 50% of the course fee must be deposited at the time of admission. Remaining fees should be paid by October 30th of the concerned year.
- 3. There is no refund policy for fees. Fee paid after the deadline carries fine.
- 4. Each student has to deposit caution money at the time of admission.
- 5. University charges may be collected from the student during the time of admission.
- 6. Age limit for admission would be as per University / State Govt. norms.
- 7. Candidates may change the subject within 15 days of commencement of the programme after payment of ₹ 1000/- per subject or ₹ 2000/- for a change of faculty.
- 8. In case a student wants to discontinue, she / he may pay the full course fee for the year, before leaving the college. Application for refund will not be considered after commencement of the programme.
- 9. Admission is valid for a year only and therefore have to be obtained for each subsequent year of study.
- 10. Students who are placed into the category of supplementary examination should take provisional admission.
- 11. The Principal may refuse or cancel admission to any individual and the decision will be final.
- 12. Permission for admission to the Annual Examination will not be granted unless:
 - a. A student has put in at least 75% attendance in each subject during the academic year.
 - b. A student has appeared for Terminal and Model Examination conducted by the College as per the norms laid down by Bastar University and has secured minimum pass marks.
 - c. Principal is satisfied with character and conduct of the student.
 - d. All dues cleared.
- 13. Students who fail to appear in the terminal and model examinations due to the unavoidable reasons will have to appear for the same on a later date decided by the college or pay penalty of at least ₹ 100/- per subject. Failure to follow the internal examinations will result in suspension from the college or debarring from University examinations as a regular student.
- 14. Each student will be issued a Photo Identity Card. The student shall always carry the card and produce it for inspection on demand. No student is allowed inside compus without his / her ID Card.
- 15. Admission to all classes closes as per the guidelines from the University.
- 16. Submission of Online Anti-ragging form is Compulsory for all students.

CODE OF CONDUCT FOR STUDENTS

- 1. All students shall arrive five minutes before the stipulated time and will leave the campus only when class hours are over.
- 2. Students shall park their vehicles at the parking lot assigned to them. Instructions of the parking in charge must be strictly observed.
- 3. Student should wear their ID cards in the college campus. In case of loss of identity card, it should be informed to the office and new identity card be applied for.
- 4. The day begins with a prayer in which each student should participate maintaining strict silence.
- 5. Students are expected to wear simple clean clothes and dress modestly. Low-waist jeans, T-shirts, sleeveless blouses, miniskirts, tights, short & flimsy attire etc. are to be avoided.
- 6. Students are expected to wear the prescribed uniform on the stipulated days.
- 7. Student shall show due respect to all faculty members both teaching and non-teaching inside and outside the campus.
- 8. Students are expected to be seated in their respective classrooms at the stroke of the bell and wait for the teacher. During lecture hours, students are not permitted to loiter in the corridors / premises.
- 9. Students should be regular and punctual in all class hours. Students must have a minimum of 75% attendance to be permitted to write the examinations.
- 10. Students who are not present in the class at the time of marking attendance will lose attendance for that period.
- 11. Loss of attendance of one period in the morning session will be treated as absent for the entire forenoon and absence for one period in the afternoon session will be treated as absent for the entire afternoon.

- 12. Total absence of any two periods on any day will be treated as absent for the full day.
- 13. If absent for three or more consecutive days on account of illness, a medical certificate should be produced along with the leave letter.
- 14. Absence without valid reason or prior permission will result in fines, ban from practicals, final exams and other activities of the college.
- 15. Tests/term exams are held periodically for every subject. Attendance for periodic tests/term exams is compulsory. Student who skip unit tests shall be fined and will have to rewrite the exams.
- 16. Every student is expected to be responsible for maintaining silence and discipline in the classroom, library, laboratory and other such places in the college and during college programmes.
- 17. Use of cell phones is strictly prohibited in class rooms. If found using, it will be confiscated and will not be returned.
- 18. Smoking, use of alcohol or narcotic drugs, use of pan masala, chewing gum etc. are strictly prohibited in the college campus. Criminal proceedings will be initiated against those found under the influence of alcohol or such drugs and items in the campus.
- 19. Carrying of any weapon or explosives inside college campus is absolutely forbidden.
- 20. Ragging is a crime punishable by law and is stictly prohibited, Being a co-educational institution, gentle behaviour and healthy friendship is expected between students.
- 21. Vandalism and destruction of college property will be severly dealt with. Any material loss will be fully recovered along with fine and punishment.
- 22. Theft of college property such as library books, computer parts, sports equipments, lab items, furniture etc. will result in expulsion and fine.
- 23. The college expects every student to be responsible for the safety of all their personal belongings including money and jewellery.
- 24. Only students who are on the rolls of the college and their parents shall enter the college campus. Inviting outsiders is prohibited.
- 25. All political activities are banned inside the college campus. College Union Election will be conducted on non-partisan basis.
- 26. Students are forbidden from organising and attending any meeting with in college, collect money for any purpose, circulate any notice or petition of any kind among the students or pasting it in the college campus without the written permission of the principal.
- 27. Criminal involvement of any student inside or outside college campus ensures automatic expulsion from college.
- 28. Students shall always promote religious harmony, social justice and national integrity.
- 29. Everyone should make conscious efforts to keep the college premises neat and clean. Throw the garbage and waste in the dustbins.
- 30. Violation of the Code of Conduct will result in disciplinary action, which includes fine, suspension and/or expulsion from the college.

रैगिंग क्या है ?

रैगिंग के अंतर्गत -

''कोलाहलपूर्ण अनुचित व्यवहार करना, चिढ़ाना, भद्दे या अशिष्ट आचरण करना, उपद्रवी एवं अनुशासनहीन क्रिया कलापों में संलग्न होना जिससे नए छात्र को गुस्सा, अनावश्यक परेशानी, शारीरिक अथवा मानसिक क्षति हो अथवा उसमें आशंका या भय बढ़ाने वाला हो, अथवा ऐसे छात्रों से ऐसा कार्य करने के लिए कहना, जो छात्र/छात्रा सामान्यतया नहीं कर सकता/सकती और जिससे उसे शर्म या अपमान का अनुभव होता हो अथवा उसके जीवन के लिए खतरा हो।

कर्नाटक शिक्षा अधिनियम, 1983 (कर्नाटक अधिनियम न. 1995) अनुरुष्य २ (२५) क अनुसार ''रैगिंग'' की परिभाषा इस प्रकार है –

''किसी छात्र को मजाक में या अन्य किसी प्रकार से ऐसा कार्य करने के लिए कहना, प्रेरित करना या बाध्य करना, जो मानव-मर्यादा के खिलाफ हो या उसके व्यक्तित्व के विपरित हो या जिससे वह हास्यास्पद हो जाए या उरा-धमकाकर गलत ढंग से रोक कर, गलत ढंग से बंद कर के या उसे चोट पहुंचा कर या उस पर अनुचित दबाव डाल कर या उसे इस प्रकार की धमकी, गलत अवरोध, गलत ढंग से बंदी बनाने, चोट या अनुचित दबाव या भय दिखाकर वैधानिक कार्य करने से मना करना।''

रैगिंग का स्वरूप

रैगिंग की निम्नांकित रूपों की सूची केवल निर्देशात्मक है, संपूर्णता में नहीं पायी जाती है :-स्पष्ट आदेश -

- सीनियर छात्रों को ''सर'' कहने के लिए
- सामूहिक कवायद करने के लिए
- सीनियरों के लिए क्लास-नोट्स उतारने के लिए
- अश्लील प्रश्न पूछने या उनका उत्तर देने के लिए
- नए छात्रों को अपने सीधेपन के विपरीत आघात पहुँचाने के हेतु अश्लील चित्रों को देखने और दिखाने के लिए
- शराब, उबलती हुई चाय, आदि पीने के लिए बाध्य करना
- कामुक संकेतार्थ वाले कार्य-समलैंगिक कार्यसहित करने के लिए बाध्य करना।
- ऐसे कार्य करने के लिए बाध्य करना, जिससे शारीरिक क्षति, मानसिक पीड़ा या मृत्यु तक हो सकती है।
- नंगा करना, चुंबन लेना आदि।
- अन्य अश्लीलताएं करना।
- उपर्युक्त से यह विदित होता है कि प्रथम पाँच को छोड़कर अधिकतर रैगिंग के विकृत रूपों से युक्त है।

रैगिंग में लिप्त होने पर दिये जाने वाले दण्ड -

- 1. प्रवेश निरस्त किया जाना।
- 2. कक्षा/छात्रावास से निष्कासित किया जाना।
- 3. छात्रवृत्ति अथवा अन्य सुविधा रोकना।
- 4. परीक्षाओं रो वंचित करना।

5. परीक्षा परिणाम रोकना

- 6. संस्था से रस्टीगेट किया जाना।
- आर्थिक दण्ड रूपये 25,000/- तक
- 8. F.I.R. दर्ज करना।
- 9. राष्ट्रीय-अन्तर्राष्ट्रीय तथा युवा-उत्सव में भाग लेने पर प्रतिबंध।
